

## **Terms & Conditions**

### **Payment**

All IPC CID courses must be paid for in full before the courseware will be issued. We recommend payment be made at least 4 weeks in advance of the course start date to allow for the suggested self-study period to be completed.

#### Courseware

Relevant courseware must be purchased with training (1 set per delegate). Courseware is non-refundable

## Transfers / Rescheduling

Requests by customer to transfer or change course dates (within 2 weeks of start date) cannot always be granted and will incur an admin fee of £150 per delegate per change. The change will not be confirmed until admin fee has been paid. Any training (including rescheduled dates) must be taken within 12 months of order, or Quadra will cancel this from our system and no refund will be offered.

### **Cancellation Policy**

Customers cancelling confirmed training dates will incur the following costs with the following notice periods, prior to the start date:

- More than 2 weeks notice no cost
- Between 1 and 2 weeks notice 50% of course fee
- Less than 1 weeks notice 100% of course fee

Scheduled training costs are kept to a minimum, to promote attendance & affordability. Subsequently we require a minimum of 2 confirmed delegates to proceed. If this criteria is not likely to be met in the 2 weeks leading up to the training, we will contact you to advise of an amended date.

#### Cancellation by Quadra Solutions

In the unlikely event that Quadra solutions has to cancel a scheduled training course, alternative dates will be offered. If for any reason delegates are unable to attend new dates, a full refund will be given.
